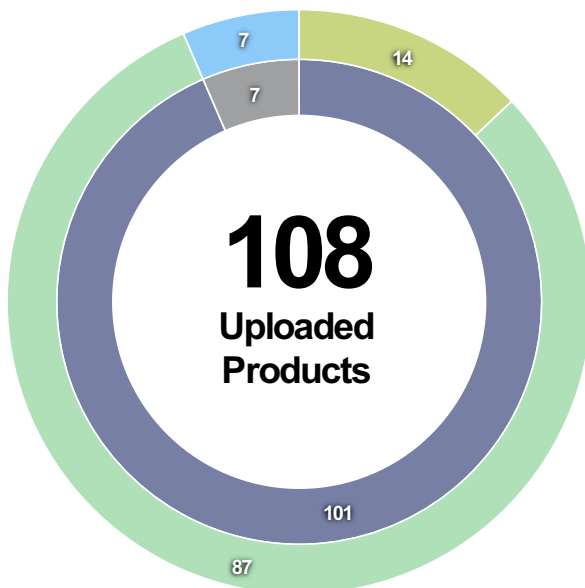
## Performance InCheck Report - April 2024

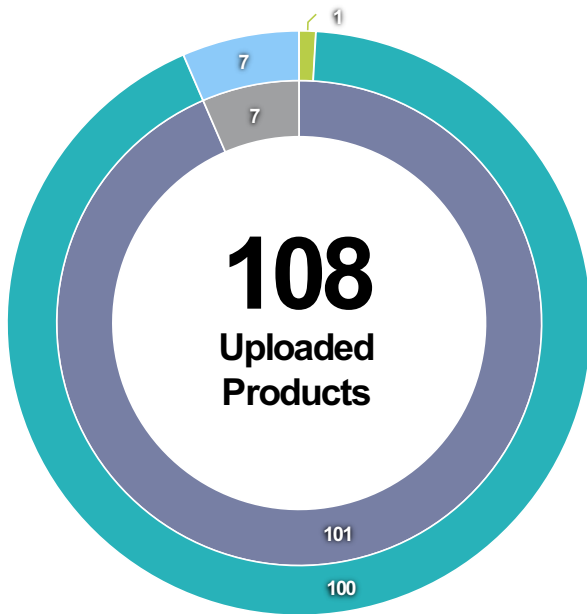

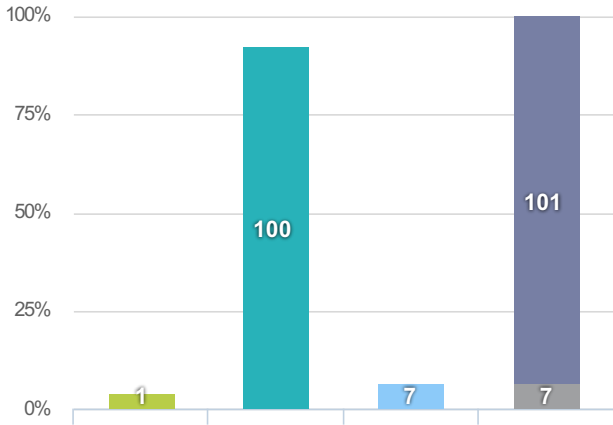

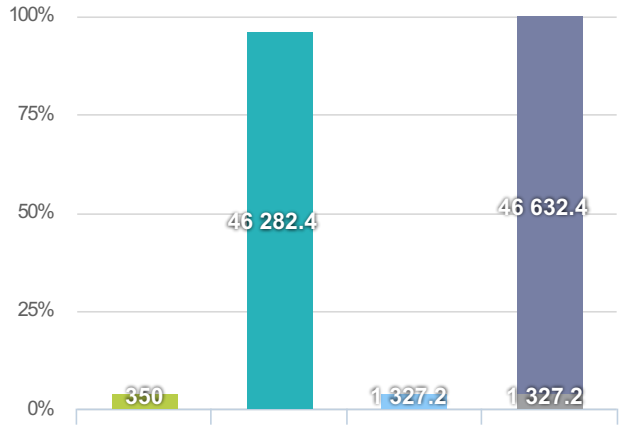
1. Identify the chemical products in your chemical inventory that are not evaluated or expired in the Chemical Inventory Performance above.
